

# C&R First Class Rentals

## RULES and REGULATIONS

**Show respect for the driver and follow the driver's instructions.**

**Client is responsible for any damages to the bus or it's equipment, accidentally or otherwise.  
Violence will not tolerated.**

- ✦ We accept money orders, cash and with proper ID, checks and credit cards ( Visa, MasterCard ).
- ✦ Cancellation Policy: If you cancel booking 7 days prior to your event, you will be responsible for 50% of the rate if we are unable to re-book your date. If cancelled later than 7 days prior to your event you will be responsible for 100% of the rate charged if we are unable to re-book your date.
- ✦ Payment of full lease is to be paid to the driver upon arrival unless full payment is paid in advance. A \$35.00 fee will be charged for returned checks or bad credit card processing.
- ✦ Starting and ending times must be enforced. (Subject to driver/bus availability.)
- ✦ "C&R First Class" is not responsible for any lost or stolen articles during the ride or articles left after the ride has ended.
- ✦ There is **NO SMOKING** allowed on the bus.
- ✦ **Alcoholic beverages are not allowed outside of the bus during the trip.**
- ✦ The "C&R First Class" driver and/or employee reserves the right to eject any individual(s) whom they deem to be disruptive, intoxicated, to pose a safety threat to themselves or to others, or deemed to be using an illegal substance.
- ✦ "C&R First Class" is not responsible for underage consumption of alcoholic beverages at any time before, during, or after the ride. Driver has the right to inspect Id's & containers of passengers who appear underage.
- ✦ "C&R First Class" cannot ,by law, supply alcohol to/for clients. Guests must provide their own alcohol.
- ✦ For any actions such as fighting, violence, damage to equipment and/or bus, harassment toward the driver, staff or anyone else in or around "C&R First Class" , the driver reserves the right to terminate the trip. The client will be responsible to find other transportation and forfeits full fare as a result.
- ✦ If a passenger should vomit in or on the bus, there will be a charge of \$100.00 payable to the driver or charged to the clients credit card. The driver will pull over when safe to do so.
- ✦ By signing up for and participating in the ride, the individual agrees that "C&R First Class" and it's employees are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.
- ✦ By signing this contract, the above client agrees to assume full responsibility for any damages to the interior or exterior of the bus that is caused by any individual riding in the bus. The client is liable for the cost to repair any such damage as well as any cost for loss of "C&R First Class" service due to such damage.
- ✦ "C&R First Class" is not responsible for injuries or accidents in and around the bus. Alcohol impairs motor skills, balance and judgment. Clients are asked to remain seated while the bus is in motion. Move about your own risk. Please use caution on steps.
- ✦ "C&R First Class" is **NOT LIABLE** in cases of unexpected vehicle breakdowns, accidents, severe weather or anything that may delay a timely arrival or cause cancellation of the trip. In the event of a cancellation due to mechanical problems, the trip may be rescheduled for another date. Client will be notified as soon as possible to let them know of unexpected problems that may postpone trip times.
